Course Description	<p>The course provides a long-run perspective on the evolution of the European economy. Focus is on output, productivity, international trade, structural change, government policies and welfare.</p> <p>The course approaches the European economy as a whole, assuming that, with all its internal differences, Europe has idiosyncratic economic features that distinguish it from other world regions. Some of the relevant events in the main countries are also covered. Emphasis will be placed on the causes and impact of the Great Recession and its aftermath.</p>
